The Board of Director meeting has unanimously approved the Agreement of New 6. The Board opinion: Cost Management System and Software License System , They noted that it is useful in the management of production costs, the director who has conflict of interest with Stanley Electric Co., Ltd. that 4 directors are Mr. Kazunori Nakai, Mr.Etsuya Kawashima, Mr.Yasuaki Kaizumi and Mr.Toru Tanabe have not right to vote and The Audit Committee has no different opinions from the Board of Directors.

The above transaction is classified as a connected transaction which a supporting ordinary and normal business transaction with outside normal commercial term , and the compensation not derived from the underlying value or assets, that charges are based on the normal practice and underlying value of assets of companies in the same industry. The transaction 24.851,905.72 baht are moderate significance level 2 more than 1 million baht or more than 0.03% (as 6,248,858.75 baht) but less than 3% (as 624,885,874.68 baht) of Net Tangible Assets of the Company (as 20,829,529,156 baht) as at March 31, 2024.

The criteria for determining value of transaction from Stanley Electric Co., Ltd. The New Cost Management System is calculated from the development cost of the program. Divided by the proportion of cost of sales of each company that as a program for cost reduction. The criteria apply to global Stanley subsidiaries., The Software License is a program developed and used in the Stanley Group calculated by the number of user who are eligible specified by each company.
