


GDP Growth 2016 – 2024 (F)


4W Market Sale (Domestic & Export) 2013 – 2023 (January – December)


4W Market Sales (Domestic & Export) 2022 - 2023 by Quarterly (January – December)


4W Market Sale (Domestic & Export) 2024 (January – March)


4W Productions 2013 – 2023 (January – December)




4W Production 2022 - 2023 by Quarterly (January – December)










2W Market Sale (2013 – 2023 January - December)






2W Market Sales 2022 - 2023 by Quarterly (January – December)






2W Market Sales 2024 - Domestic (January – March)




2W Productions 2013 – 2023 (January – December)






2W Production 2022 - 2023 by Quarterly (January – December)








