Subject To clarify the operating results of Quarterly 2 / 2025

Attention President

The Stock Exchange of Thailand

Thai Stanley Electric Public Company Limited would like to clarify the operating results for the quarterly 2/2025 as follows:

- Sales

In the second quarter (July 1 - September 30, 2025), the company's total sales were 3,074.26 million baht, a decrease of 156.69 million baht, representing a 4.85% decrease from the same period in 2024, which had sales of 3,230.95 million baht. This was due to the continued economic downturn both domestically and internationally, high household debt, and stricter lending policies by financial institutions, which affected vehicle sales and production, particularly for internal combustion engine vehicles directly related to the company.

In the motorcar, production in July - September 2025 totaled 351,086 units, decrease from 366,786 units in the same period of 2024 or a decrease of 4.28%. Exports sale totaled 229,674 units, decrease from 249,847 units in the same period of 2024 or a decrease of 8.07%. Meanwhile, domestic sales totaled 145,275 units, increase from 130,632 units in the same period of 2024 or an increase of 11.21%, primarily driven by electric vehicles (EVs).

In motorcycles, production in July-September 2025 reached 472,950 units, an increase from the same period in 2024, when production was 441,781 units, representing an increase 7.06%. Domestic sales were 409,181 units, increase from 391,177 units in the same period of 2024, representing an increase 4.60%.

- Net Profit

In the second quarter (July 1 - September 30, 2025), the company had a net profit of 616.56 million baht, an increase of 88.46% from the same period in 2024, which had a net profit of 327.16 million baht. This is because in the second quarter of 2024, the company recorded an asset impairment loss of 218.43 million baht due to production restructuring, combining Lamp Factory 1 and Lamp Factory 5 with Lamp Factory 2, Lamp Factory 7, and Lamp Factory 8, which resulted in lower production costs and this was also due to strict cost control throughout the company.
